## Synopsis of the Genus *Ficus* L. (Moraceae) in India

**ABSTRACT:** A checklist of all species of *Ficus* L. available in the present political boundary of India is provided. About 115 taxa (89 species and 26 infraspecific taxa) of *Ficus* have been recorded here based on all available information. The taxa have been arranged according to the current classification among six subgenera and 12 sections. The maximum number of the species belongs to subgenera *Urostigma*. For each species, correct nomenclature with first citation followed by several relevant works and important synonyms has been provided along with Indian as well as world distribution. The taxonomic comments have also been provided for many species, if found necessary. Out of the 115 taxa occurring in India, only 10 taxa have been recorded as endemic. One new combination *Ficus hirta* Vahl subsp. *triloba* (Buch.-Ham. ex Voigt) Chaudhary has been proposed. In India, the species are distributed throughout the country from South to North up to the Himalayas at about 2,000 m elevations. The maximum diversity of the species lies in the North-East region followed by the Peninsular region and Andaman and Nicobar Islands. The province like Meghalaya in the North-East region has very rich diversity of *Ficus* as far as the number of species is concerned.

## INTRODUCTION

*Ficus* L., commonly known as 'Fig', is considered as a keystone species in tropical rain forests as it plays very fundamental role in ecosystem, due to its fruits which are eaten by insects, birds and animals throughout the year. It is one of the largest genera in the angiosperms with ca. 750 species. The genus is distributed throughout the world primarily in subtropical and tropical regions (Corner, 1965; Berg, 1989; Berg and Corner, 2005). The main concentration of the species lies in Asian-Australian region with about 500 species which is about 66% of the world species. The maximum diversity of the genus exhibits in Asiatic mainland (170 spp.), New Guinea (132 spp.) and Borneo (129 spp.). Many species of *Ficus* L. are very common in different biogeographic regions. Although, the great majority of the species grow in lowlands but some of them reach up to about 2,000 m altitudes. *Ficus* is also considered one of the most diversified genera with regard to its habits (deciduous and evergreen trees, shrubs, herbs, climbers and creepers) and life forms (free standing tree, epiphytes, semi-epiphytes in the crevices, rheophytes and lithophytes).

The first systematic account of the Indian *Ficus* L. is available in King (1887-88, 1888); therein he recorded 113 species and 47 infraspecific taxa from whole British India out of which only 75 species and 16 infraspecific taxa were reported from the present political boundary

of India. Subsequently, a large number of works have been carried out either at regional or global levels (Corner, 1958, 1965, 1969, 1975, 1981; Yamazaki, 1983; Berg, 1989, 2001, 2003, 2004 a, b; Liao, 1996; Kochummen, 1998; Chang and Wu, 1998; Dixon, 2003; Wu et al., 2003; Burrows and Burrows, 2003; Tzeng, 2004; Berg and Corner, 2005; Tzeng et al., 2009) bringing substantial changes in identification, circumscription, nomenclature, distributional pattern etc. of the species which make the work of King (1887-88, 1888) almost outdated. Although the Asian species of *Ficus* have been worked out by Corner (1965), however, till date no separate account of the Indian species of *Ficus* except some scattered works (Rani, 1985; Ghafoor, 1985; Sreekumar and Debnath, 1992; Basu, 1994, 1996; Khanna, 1996; Sreekumar, 1998; Sasidharan and Jomy Augustine, 1999; Priyadarsana, 1999; Khanna and Anand, 2002, 2009; Pandey and Rasingam, 2008; Abdul Kader, 2009; Upadhyay and Srivastava, 2010; Kumar et al., 2011) has been produced after King (1888). In view of this, the genus *Ficus* L. from India has been selected for its revisionary study. Since there is no any comprehensive list of *Ficus* L. from India has been brought out in the recent time after King (1888), firstly a checklist of all species is presented here based on available information.

In the family Moraceae, *Ficus* L. is quite distinct from other groups and hence placed in its own tribe *Ficeae*. In molecular phylogenetic study of Moraceae



based on *ndhF* sequences, the tribe *Castilleae* has been shown closest to *Ficus* (Datwyler and Weiblen, 2004). Recently, the genus has been classified into six subgenera, 19 sections and 27 subsections based on morphological features and distributional pattern (Ramirez, 1977; Berg and Corner, 2005). Some of the subsections like *Hesperidiiformes* and *Platypodeae* have been further divided into series. In this classification the molecular data have not been considered. However, the DNA sequence-based phylogenetic studies have shown that taxonomic categories of *Ficus* L. based on morphological characters are not natural and revealed several parallel transitions in growth habit and breeding system (Herre et al., 1996; Weiblen, 2000; Joussetin et al., 2003; Ronsted et al., 2005). Further, the recent molecular studies (Ronsted et al., 2008 a,b) conducted on a large number of samplings (100 species) than previous studies using three nuclear markers (ITS, ETS and *G3pdh*) also do not support subgeneric or sectional classification of the genus proposed on morphological characters except subgenus *Sycidium*. As per the existing classification, the Indian species of *Ficus* L. belong to all six subgenera under 12 sections and 15 subsections. The majority of the species fall within the subsections *Urostigma* and *Conosycea* under section *Urostigma* of subgenus *Urostigma*.

## MATERIALS AND METHODS

The study is based on extensive literature scrutiny as well as our own field survey and herbarium examination. The taxa have been enumerated as per existing classification system (Ramirez, 1977; Berg and Corner, 2005). Under each species, the synonyms have been arranged chronological order except basionym. Apart from the first citation the other relevant references pertaining to the Indian flora have also been cited wherever found necessary under correct name or synonyms. The nomenclature has been followed by distribution under which the country names have been arranged alphabetically except India. The taxonomic notes have also been provided at the end of the species.

## RESULTS

In the present analysis 115 taxa of *Ficus* L. have been recorded from India out of which 89 are species and remaining 26 taxa fall under different infraspecific categories (6 subspecies and 20 varieties). The genus is distributed throughout the country from South to North up to the Himalaya at about 2,000 m elevations. However, the maximum diversity of the species lies in North-East (ca. 61 spp.) and Peninsular regions and Andaman and Nicobar Islands with ca. 35 species each.

Among all the Indian provinces, Meghalaya in the North-East region alone consists of about 43 species and may be considered as the hotspot region in India for the genus *Ficus* L. For each species, correct nomenclature with first citation followed by several relevant works and important synonyms have been provided along with the Indian as well as world distribution. The taxonomic comments especially on identification, nomenclature and distribution of the species have also been provided for many species, wherever found necessary. Out of the 115 taxa distributed in India, only 10 are endemic. One new combination *Ficus hirta* Vahl subsp. *triloba* (Buch.-Ham. ex Voigt) Chaudhary is proposed here.

Phytogeographically, the Indian figs exhibit affinities with the elements of Indochinese (ca. 65 spp.) and Indomalayan (ca. 90 spp.) regions. Only about 10 species chiefly occurring in the N. W. Himalaya extend their distribution towards westward of Pakistan. There are about 46 species which are found in both Indochinese as well as Indomalayan regions. The species available in the North-East region chiefly show affinities with Chinese elements while the species of the Peninsular region and Andaman and Nicobar Islands with Indomalayan region. Only a few species reach up to Australia. The American elements are completely absent here.

## TAXONOMIC TREATMENT

Distribution: India (Cultivated throughout), East Mediterranean, West Asia, Turkey to Afghanistan. Widely cultivated for figs.

Distribution: India (Andhra Pradesh, Bihar, Kerala Madhya Pradesh, North-West Himalaya up to 1,700 m, Orissa, Rajasthan, Uttar Pradesh, Sometimes cultivated), Afghanistan, Arabian Peninsula, Ethiopia, S. Egypt, Iran, Nepal, Pakistan, Somalia, Sudan.

Note: Quite common and variable in height of the plants and leaf shape and size. In majority of the Indian floras this species has been identified as *F. palmata* Forsk., which occurs only in E. Africa and Saudi Arabia. The Indian materials belong to ssp. *virgata* (Roxb.) Browicz.

Distribution: India (Assam, Sikkim, Meghalaya), China, Japan, S. Korea, Taiwan, Vietnam.

Note: Although *F. erecta* Thunb. var. *beecheyana* (Hook. & Arn.) King and *F. erecta* Thunb. var. *sieboldi* (Miq.) have been merged under *F. erecta* Thunb.; however, they need to be re-examined taxonomically.

Notes: Corner (1965) has treated *F. neriifolia* J. E. Sm. var. *nemoralis* (Wall. ex Miq.) Corner, *F. neriifolia* J. E. Sm. var. *fieldingii* (Miq.) Corner and *F. neriifolia* J. E. Sm. var. *trilepis* (Miq.) Corner separately. However, Wu et al. (2003) have merged all of them under *F. neriifolia* J. E. Sm. Since, receptacles are distinguishable among them, they need further studies.

## 印度榕屬(桑科)植物之概要整理

摘要：本文提供了一份在印度境內所有榕屬植物的清單，共包含115個分類群（89個種和26個種下分類群）。而本清單將此115個分類群又分為6個亞屬及12個節，其中物種數最豐富的亞屬為 *Urostigma*。本文除描述每個物種在印度境內及世界上的分佈外，也提供了該物種同種異名之相關文獻，並針對數個物種提出分類上的意見。在此115個分類群中只有10個分類群是印度的特有種；本文也建議將亞種 *Ficus hirta* Vahl subsp. *triloba* (Buch.-Ham. ex Voigt) Chaudhary 做合併處理。在印度境內榕屬物種多樣性最高處落在東北半島如梅加拉亞邦以及安達曼-尼科巴群島，兩個區域都具有引人注目的高物種多樣性存在。
